

# Voya File Specification for Mandatory Roth Catch-up(MRC) Indicator File

## 1. MRC Indicator File

- File specification for receiving Mandatory Roth Catch-up(MRC) indicator from employers/clients.
- File type = csv (extension can be .csv/.CSV) – Comma(,) delimited file

## 2. Filename & Folders

- **Client/Employer → Voya**

5	MRC Indicator	Y or N (1 Character)	<ul style="list-style-type: none"> <li>▪ Mandatory</li> <li>▪ Should be valued as <b>Y</b> or <b>N</b></li> <li>▪ Values other than Y/N will be treated as N</li> <li>▪ Y = Participant is Mandatory Roth Catch-up(MRC) for the year referenced in Field#4</li> <li>▪ N = participant is not MRC for Year referenced in Field#4</li> </ul>
