#### Voya Financial

An annual record-keeping fee of \$35.50 will be deducted from your account on a monthly basis (approximately \$2.96 per month) and is in addition to fund annual operating expenses. If you participate in more than one VRS Defined Contribution Plans, only one annual fee of \$35.50 will be deducted from your account. Fund performance returns shown reflect fund management fees and expenses, but do not reflect Voya Financial fees which would further reduce the returns shown.
