

## Important information

about installment payments for Virginia
Retirement System Defined Contribution Plans

**Starting January 1, 2025:** Voya Financial® (Voya)\* will become the record keeper for Virginia Retirement System Defined Contribution Plans (VRS DCP).

The deadline to request a withdrawal through MissionSquare Retirement\*\* is before 4 p.m. on December 20, 2024. Payments not processed at MissionSquare will be processed by Voya as soon as administratively possible the week of January 6, 2025.

## Plans impacted by this change\*\*\* include:

- Hybrid Retirement Plan Defined Contribution Component
- Commonwealth of Virginia 457 Deferred Compensation Plan
- Virginia Cash Match Plan
- Optional Retirement Plan for Higher Education
- Optional Retirement Plan for Political Appointees
- Optional Retirement Plan for Superintendents
- · Virginia Supplemental Retirement Plan

You are receiving this notice because the records transferred from MissionSquare indicate you have installment payments in place from one or more of the above plans.

## This letter advises you of two important changes:

 Banking and Tax Withholding Information WILL transfer automatically to Voya. If you currently have banking and/or tax withholding information on file with MissionSquare, this information WILL transfer.

- 2. The date of your installment payments may change. Please plan accordingly.
  - a. If your pay date is the 1st to the 14th, your installment payment will be processed by Voya on the 1st of the month.
  - b. If your pay date is the 15th to the end of the month, your installment payment will be processed by Voya on the 15th of the month.
